- » For a nomination to be considered, it must be accompanied by a detailed biography of the individual, which includes the nominee's industry involvement.
- » Submissions will be reviewed by a committee consisting of the previous "Old Salt" winner, the Merchants Exchange Executive Director, and the Maritime Commerce Club President.

- 6. What companies/organizations has the nominee been involved with?
- 7. What organization(s) is the nominee currently involved with?
- 8. How has the nominee advanced the Columbia and/or Willamette River maritime industry?
- 9. How has the nominee been a contributor to the maritime community?
- 10. Has the nominee made a significant effort to progress the industry outside of their regular job activities?
